1220.01 ESTABLISHMENT; MEMBERSHIP.

There is hereby established a Planning Commission in and for the Village, consisting of the following five members: the Mayor, a member of Council and three citizens of the Village who shall serve without compensation and who shall be appointed by the Mayor and approved by Council for a term of six years, except that the term of one of the citizen members of the first Commission shall be for four years and one for two years. (Ord. 1983-2. Passed 7-11-83.)

1220.02 POWERS.

The powers of the Planning Commission shall be those granted by Ohio R.C. Chapter 713, by all other sections of the Ohio Revised Code and of the Constitution of the State now in effect or which may hereafter be passed and effective and relating to village planning commissions, and by all ordinances passed by Council relating to the Commission. (Ord. 1983-2. Passed 7-11-83.)

1220.03 CONTROL OF BUILDING CONSTRUCTION; RULES AND REGULATIONS.

The Planning Commission is authorized to control the height, design and location of buildings within its jurisdiction and to issue and make rules and regulations relating thereto, all in accordance with the provisions of Ohio R.C. 713.04. (Ord. 1983-2. Passed 7-11-83.)

1220.04 PLANNING COMMISSION TO BE BOARD OF ZONING APPEALS.

Pursuant to Ohio R.C. 713.11, the powers, duties and authority of the Board of Zoning Appeals, as established in Section 1225.03 of the Zoning Code of the Village, shall be vested in the Planning Commission, as established in Section 1220.01. (Res. 1999-71. Passed 12-20-99.)




The Mayor is authorized to enter into a contract from time to time for zoning administration services in and for the Village.
